Creation of a Pool of Trained Geriatric Caregivers for Senior Citizens

The Senior Citizens have certain age related requirements especially the Indigent and abundant or who suffer mobility restrictions, or bed ridden. As the society is moving towards nuclear families where both the partners are working and has the capacity to engage a better trained care giver if available.

The COVID 19 Pandemic has also reflected the need for the trained caregivers both in old age homes and individual thus there is significant to meet the shortage of caregivers in the coming years to provide qualitative services to the senior citizens as per their specific needs.

The State has 33 districts and divided into 7 zones i.e., Basara(4 districts), Bhadradri(5 districts), Kaleshwaram(5 districts), Rajanna(5 districts), Charminar(5) districts), Jogulamba(5 districts), and Yadradri(4 districts), it is proposed to provide training to (100) geriatric care givers by conducting two training programs in each zone.

To make this program more sustainable and handhold these training programs to improvise the bedside assistance services offered in Old Age Homes.

Further, below are the proposed eligibility criteria for providing trainings:

Eligibility Criteria

- 1. NGO applying shall have vast experience in providing Trainings on Geriatric Care giving.
- 2. NGOs present/previous handling/handled similar training programs of Govt. of India/State Government will be given preference.
- 3. NGO applying shall be open to travel all (7) zones i.e., Basara(4 districts), Bhadradri(5 districts), Kaleshwaram(5 districts), Rajanna(5 districts), Charminar(5) districts), Jogulamba(5 districts), and Yadradri(4 districts) to conduct trainings.
- 4. The organization shall have the financial fusibility to organize the training programs. The funds will be released as per the guidelines.
- 5. The preference will be given to the RRTC (Regional Resource Training Center) working under Ministry of Social Justice & Empowerment, Govt. of India in Telangana(TG) State.

- 6. Shall conduct training to (50) care givers for a period of (24) days with accommodation including tea, Tiffin's, lunch at one location of each zone. Totally (2) training programmes shall be conduct in each zone by the NGOs.
- 7. The training programs shall conduct at (1) district location in each zone.
- 8. Each training program shall cover (50) care givers and shall conduct for a period of (24) days with proper accommodation including tea, Tiffin's, snacks, lunch and dinner and other miscellaneous.
- 9. Only physical proposals are invited and online proposals are not entertained.
