3. In the reference 4th read above, orders were issued to change of nomenclature of HOD i.e., Department for Welfare of Disabled & Senior Citizens" as "Department for Empowerment of Persons with Disabilities, Senior Citizens and Transgender Persons".

4. Government after careful examination of the matter, hereby ordered in supersession of orders issued in the reference 1st cited, the following with immediate effect:
