In the reference 8th read above, the Director, Department for Empowerment of Persons with Disabilities, Senior Citizens and Transgender Persons, Hyderabad has requested to enhance Marriage Incentive Award, for the marriage between two persons with disabilities from 1.00 Lakh to 2.00 Lakhs to provide substantial financial support to the newlywed couple and to foster a more secure environment for improving their overall quality of life.
