- 3. Government after careful examination of the matter, hereby approve and issue revised guidelines for sanction of Aids & Appliances to the Persons with Disabilities, which are Annexed to this order.
- 4. The Director, Department for Empowerment of Persons with Disabilities, Senior Citizens & Transgender Persons and Ex-officio Joint Managing Director, TVCC, Hyderabad is permitted to fix the dates for calling applications through OBMMS for supply of Aids & appliances to the eligible persons with Disabilities.

5. The Director, Department for Empowerment of Persons with Disabilities, Senior Citizens & Transgender Persons and Ex-officio Joint Managing Director, TVCC, Hyderabad shall take necessary action accordingly.

# 1. <u>Guidelines for Sanction of Retrofitted Motorized Vehicles (Petrol Scooter) to the Persons with Locomotor Disability.</u>

## I. Target Group:

Persons with Locomotor Disability of 40% and above (both/single lower limbs are affected but upper limbs shall be normal) studying regular degree/equivalent and above courses and those who are unemployed Locomotor Disabled having minimum SSC Pass.

## II. Eligibility:

- Student must be studying regular Degree/any equivalent and above Courses.
- 2. Student must be attending the Classes regularly.
- 3. Unemployed Locomotor disabled those who are possessing minimum SSC (Pass)
- 4. Annual income should not exceed Rs.2,00,000/- in urban areas and Rs.1,50,000/- in rural areas.
- 5. Age limit:
  - a) students 18 to 55 years.
  - b) Unemployed Locomotor disabled 18 to 55 years.
- 6. The candidates should not have availed Motorized Vehicle/Subsidy previously from Disabled Welfare Department/TVCC or any other Department or Government Agency.
- 7. No candidate shall be considered for sanction of more than one device/appliance.
- 8. The Retrofitted Motorized Vehicle will be distributed once in lifetime only to the individual.
- 9. Students/unemployed Locomotor disabled (40% & above disabilities) both/single lower limbs are affected but upper limbs shall be normal.

## III. Process and Sanction:

- 1. The Applicant should submit application through OBMMS (<a href="https://tgobmms.cgg.gov.in">https://tgobmms.cgg.gov.in</a>) duly filling all the Columns and upload the following documents.
  - (i) Aadhaar Card.
  - (ii) Disability Certificate (SADAREM/UDID) issued by the competent authority as notified by the Government from time to time.
  - (iii) Bonafide Certificate from the institution.
  - (iv) Residential Certificate issued by Tahsildars (or) Ration Card (or) Aadhaar Card (or) Voter ID (or) any other document showing proof of residence.
  - (v) Ration Card, if Ration Card is not available, the candidate shall submit latest Income Certificate issued by concerned Tahsildar within one year.
  - (vi) Proof of Age: (SSC Certificate).
  - (vii) Caste Certificate in case of SC/ST.
  - (viii) Unemployed Locomotor Disabled should submit a self-declaration stating that he/she is self-employed on Rs.100/- non judicial stamp paper with attestation of a Notary.
- 2. The selection & sanction of beneficiary will be finalized by the District Screening Committee. Sanction proceedings shall be issued by District Collector.
- 3. The following order of priority shall be followed in selection of beneficiaries.
  - a) First Priority shall be given to Disabled students studying Degree and above Course.
  - Either for students or unemployed higher degree of disability shall be given preference.
  - c) Either for students or unemployed higher age group shall be given preference.

4. The District Welfare Officer/Assistant Director should send the sanction proceedings of the District Collector to the Joint Managing Director, TVCC for supply and release.

5. The District Welfare Officer/Assistant Director should maintain seniority register of applications received, sanctions made & distributed to beneficiary along with beneficiary acknowledgement.

6. The District Welfare Officer/Assistant Director shall also maintain the stock register at district level.

3. Reservation pertaining to SC, ST and 33½ % quota for Women should be followed. In case, sufficient applications are not received against the reserved quota pertaining to SC, ST and Women, such leftover units shall be allotted to General Quota by the District Selection Committee at the time of Selection in the same selection process in the same year.

4. The applicant should be a native of Telangana.

5. The applicant should possess driving license for the invalid carriage.

## VI. Punishment for fraudulently availing any benefit meant for Persons with Disabilities:

Whoever fraudulently avails or attempts to avail, any benefit meant for Persons with benchmark disabilities, shall be punishable with imprisonment for a term which may extend to two years or with fine which may extend to one lakh or with both as prescribed under Section 91 of the Rights of Persons with Disabilities Act, 2016. In such cases, in addition to the prosecution, recovery under Revenue Recovery Act, as per the rules in force will be initiated.

# 2. <u>Guidelines for Sanction of Battery Wheelchairs to the Persons affected with Muscular Dystrophy, Spinal Cordinjury and Locomotor Disability</u>

## I. Target Group:

To provide Battery Wheelchairs to the Persons affected with Muscular Dystrophy, Spinal Cord injury having minimum of 40% disability and the candidates suffering from Locomotor Disability affected with both lower limbs having 80% & above disability may also be considered.

### II. Eligibility:

- 1. Persons affected with Muscular Dystrophy, Spinal Cord injury having minimum of 40% disability.
- 2. The candidates suffering from Locomotor Disability affected with both lower limbs having 80% & above disability may also be considered.
- 3. Annual income should not exceed Rs.2,00,000/- in urban areas and Rs.1,50,000/- in rural areas.
- 4. Age limit: 12 -55 years.

5. No candidate shall be considered for sanction of more than one device/appliance.

6. The individual will become eligible for Battery Wheelchair once in (5) years.

## III. Process and Sanction:

- 1. The Applicant should submit application through OBMMS (<a href="https://tgobmms.cgg.gov.in">https://tgobmms.cgg.gov.in</a>) duly filling all the Columns and upload the following documents.
  - (i) Aadhaar Card.
  - (ii) Disability Certificate (SADAREM/UDID) issued by the competent authority as notified by the Government from time to time.
  - (iii) Residential Certificate issued by Tahsildars (or) Ration Card (or) Aadhaar Card (or) Voter ID (or) any other document showing proof of residence.
  - (iv) Ration Card, if Ration Card is not available, the candidate shall submit latest Income Certificate issued by concerned Tahsildar within one year.
  - (v) Proof of Age: Aadhar (or) any other certificate for age proof.
  - (vi) Caste Certificate in case of SC/ST.
- 2. The selection & sanction of beneficiary will be finalized by the District Screening Committee. Sanction proceedings shall be issued by District Collector.
- 3. The District Welfare Officer/Assistant Director should send copy of sanction proceedings of the District Collector to the Joint Managing Director, TVCC.
- 4. The District Welfare Officer/Assistant Director should maintain seniority register of applications received, sanctions made & distributed to beneficiary along with beneficiary acknowledgement.
- 5. The District Welfare Officer/Assistant Director shall also maintain the stock register at district level.
- 6. The following order of priority shall be followed in selection of beneficiaries.
  - First Priority shall be given to the PwDs suffering from Muscular Dystrophy and Spinal Cord Injured.
  - b) Priority shall be given to higher degree of disability.

In case, sufficient applications are not received against the reserved quota pertaining to SC, ST and Women, such leftover units shall be allotted to General Quota by the District Selection Committee at the time of Selection in the same selection process in the same year.
- 4. The applicant should be a native of Telangana State.

### VI. Punishment for fraudulently availing any benefit meant for Persons with Disabilities:

Whoever fraudulently avails or attempts to avail, any benefit meant for Persons with benchmark disabilities, shall be punishable with imprisonment for a term which may extend to two years or with fine which may extend to one lakh or with both as prescribed under Section 91 of the Rights of Persons with Disabilities Act, 2016. In such cases, in addition to the prosecution, recovery under Revenue Recovery Act, as per the rules in force will be initiated.

## 3. <u>Guidelines for sanction of Mobile Business Battery Tricycles</u> (Empower Cart) for Persons with Locomotor Disability.

## I. Target Group:

Unemployed Persons with Locomotor Disability (both/single lower limbs are affected but upper limbs shall be normal) who studied  $9^{\rm th}$  Class & below are eligible.

## II. Eligibility:

- 1. Unemployed Persons with Locomotor disability who studied 9<sup>th</sup> Class & below are eligible.
- 2. Unemployed Locomotor disabled having 40% & above disability.
- 3. Annual income should not exceed Rs.2,00,000/- in urban areas and Rs.1,50,000/- in rural areas.
- 4. Age limit for unemployed Locomotor disabled is 18 to 55 years.
- 5. No candidate shall be considered for sanction of more than one device/appliance.
- 6. The individual will become eligible for Mobile Business Battery Tricycle (Empower Cart) once in (5) years.

- 1. The Applicant should submit application through OBMMS (<a href="https://tgobmms.cgg.gov.in">https://tgobmms.cgg.gov.in</a>) duly filling all the Columns and upload the following documents.
  - (i) Aadhaar Card.
  - (ii) Disability Certificate (SADAREM/UDID) issued by the competent authority as notified by the Government from time to time.
  - (iii) Ration Card, if Ration Card is not available, the candidate shall submit latest Income Certificate issued by concerned Tahsildar within one year.
  - (iv) Residential Certificate issued by Tahsildars (or) Ration Card (or) Aadhaar Card (or) Voter ID (or) any other document showing proof of residence.
  - (v) Proof of Age: Aadhar (or) any other certificate for age proof.
  - (vi) Caste Certificate in case of SC/ST.

- 6. The District Welfare Officer/Assistant Director should maintain seniority register of applications received, sanctions made & distributed to beneficiary along with beneficiary acknowledgement.

# 4. Guidelines for Sanction of Battery Mini Trading Auto Vehicles for self-employment to the Persons with Locomotor Disability.

## I. Target Group:

Unemployed Persons with Locomotor Disability (both/single lower limbs are affected but upper limbs shall be normal) who have SSC & below Qualification for seeking employment since (3) years are eligible.

### II. Eligibility:

1. Unemployed Persons with Locomotor Disability having minimum educational qualification of SSC & below.

2. Unemployed Persons with Locomotor disabled having 40% & above disability.

3. Annual income should not exceed Rs.2,00,000/- in urban areas and Rs.1,50,000/- in rural areas.

4. Age limit for unemployed Locomotor disabled 18 to 55 years.

5. The candidates should not have availed Motorized Vehicle/Subsidy previously from Disabled Welfare Department/TVCC or any other Department or Government Agency.

6. No candidate shall be considered for sanction of more than one device/appliance.

7. The Battery Mini Trading Auto Vehicle will be distributed only once in lifetime to the individual.

- 1. The Applicant should submit application through OBMMS (<a href="https://tgobmms.cgg.gov.in">https://tgobmms.cgg.gov.in</a>) duly filling all the Columns and upload the following documents.
- (i) Aadhaar Card.
- (ii) Disability Certificate (SADAREM/UDID) issued by the competent authority as notified by the Government from time to time.
- (iii) Study Certificate.
- (iv) Ration Card, if Ration Card is not available, the candidate shall submit latest Income Certificate issued by concerned Tahsildar within one year.
- (v) Residential Certificate issued by Tahsildars (or) Ration Card (or) Aadhaar Card (or) Voter ID (or) any other document showing proof of residence.
- (vi) Proof of Age: Aadhar (or) any other certificate for age proof.
- (vii) Caste Certificate in case of SC/ST.

Persons with Locomotor Disability affected by lower limbs (both upper limbs shall be normal) students/ unemployed are eligible.

### II. Eligibility:

- 1. Persons with Locomotor Disability affected by lower limbs (both upper limbs shall be normal) students/ unemployed are eligible.
- 2. Students must be studying Intermediate/any equivalent and above Courses.
- 3. Unemployed Locomotor disabled or those who are self-employed with minimum intermediate qualification.
- 4. Students/unemployed having 40% & above disability.
- 5. Annual income should not exceed Rs.2,00,000/- in urban areas and Rs.1,50,000/- in rural areas.
- 6. Age limit for bonafide students and unemployed Locomotor disabled is 18 to 55 years.
- 7. The candidates should not have availed Motorized Vehicle/Subsidy previously from Disabled Welfare Department/TVCC or any other Department or Government Agency.
- 8. No candidate shall be considered for sanction of more than one device/appliance.
- 9. The individual will become eligible to Hybrid Wheelchair Attachment + Wheelchair once in (5) years.

  - (iii) Bonafide Certificate from the institution.
  - (iv) Residential Certificate issued by Tahsildars (or) Ration Card (or) Aadhaar Card (or) Voter ID (or) any other document showing proof of residence.
  - (v) Ration Card, if Ration Card is not available, the candidate shall submit latest Income Certificate issued by concerned Tahsildar within one year.
  - (vi) Proof of Age: SSC Certificate/ Aadhar Card.
  - (vii) Caste Certificate in case of SC/ST.
- 2. The selection & sanction of beneficiary will be finalized by the District Screening Committee. Sanction proceedings shall be issued by District Collector.

5. The District Welfare Officer/Assistant Director should maintain seniority register of applications received, sanctions made & distributed to beneficiary along with beneficiary acknowledgement.

The District Welfare Officer/Assistant Director shall also maintain the

stock register at district level.

#### 6. Guidelines for sanction of Laptops to the Visually Impaired and Hearing Impaired Students studying Degree/Equivalent Courses.

#### I. **Target Group:**

To provide Laptops to Visually Impaired and Hearing Impaired Students those who are studying Degree/Equivalent Courses.

#### II. Eligibility

1. Visually Impaired and Hearing Impaired Students must be studying regular Degree/equivalent Courses.

2. Student must be attending the Classes regularly.

- 3. The Laptops will be sanctioned to Visually Impaired students with 50%& above disability and Hearing Impaired with 51% & above disability.
- 4. Annual income should not exceed Rs.2,00,000/- in urban areas and Rs.1,50,000/- in rural areas.
- 5. Age limit: 18 to 55 Years.
- 6. The individual will be eligible for Laptop once in (5) years.

- 1. The Applicant should submit application through OBMMS (<a href="https://tgobmms.cgg.gov.in">https://tgobmms.cgg.gov.in</a>) duly filling all the Columns and upload the following documents.
  - (i) Aadhaar Card.
