ORDER:-

In the G.O 1st read above, orders were issued enhancing the subsidy for implementation of Economic Support Schemes to Differently Abled persons from Rs.3,000/- to Rs.30,000/- or 50% of project cost whichever is less on par with Scheduled Caste/Scheduled Tribes and the annual family income limit from Rs.11,000/- to Rs.1,00,000/- to ensure that the Scheme is implemented as a Bankable Scheme and that every unit should be grounded with 50% Bank Tie-up and also issued guidelines to sanction enhanced subsidy.

2. In the reference 2nd read above, the Director, Welfare of Disabled & Senior Citizens Department has requested the Government to enhance subsidy rate and relax age criteria for Economic Rehabilitation Schemes being implemented by the Welfare of Disabled & Senior Citizens Department for socio-economic upliftment of persons with disabilities.

3. Government, after careful examination of the matter hereby accord sanction to enhance the existing subsidy and to revise the age criteria for implementation of Economic Support Scheme to Differently Abled Persons as detailed below. It is to be ensured that the scheme is implemented as a Bankable scheme and that every unit should be grounded with Bank tie-up as detailed below. The guidelines in annexure to the reference 1st cited, with tabular modification detailed below shall be followed for implementation of the Economic Support Schemes. The revised enhancement of rate of subsidy and age criteria will be operative from the date of issue orders.

4. The Director, Welfare of Disabled & Senior Citizens, Hyderabad shall take necessary action accordingly.
