In the reference 1 read above, Government of India has enacted the Transgender Persons (Protection of Rights) Act, 2019 for protection of rights of transgender Persons and their welfare. In the reference 2^{od} read above, Government of India has framed rules for protection of rights of transgender Persons.

2. In the reference 3^d read above, the Director, Welfare of Disabled and Senior Citizens, Hyderabad has submitted proposal for constitution of State Welfare Board for the Transgender Persons for protecting rights and interests, as per Rule- 10 (1) of Transgender Persons (Protection of Rights) Rules, 2020 issued by Government of India.

3. Government after careful examination of the proposal of the Director, Welfare of Disabled and Senior Citizens, Hyderabad hereby constitute State Welfare Board for the Transgender Persons in Telangana State with the following Members:

Functions of the Board:

- a) To Advise the State Government on the formulation of Policies, Programmes, legislation and projects with respect to Transgender persons.
 - b) To Monitor and evaluate the impact of policies and programmes designed for achieving equality and full participation of transgender persons.
 - c) To review and coordinate the activities of all the departments of Government and of her Governmental and non-Governmental organizations which are dealing with matters relating to transgender persons and
 - d) To perform such other functions as may be prescribed by the State Government.
4. The tenure of the above Committee shall be for a period of 2 years.
5. The above said Committee shall meet at least once in six months to advise the State Government on effective implementation of the Act and to perform such other functions in relation to Transgender.
6. The Director, Welfare of Disabled and Senior Citizens, Hyderabad shall take necessary action accordingly.
