## ORDER:-

Whereas, by section 101 of the Andhra Pradesh Re-Organization Act, 2014 (Central Act No.6 of 2014) the appropriate Government i.e., the State of Telangana is empowered by order, to make such adaptions and modifications of any law made before 02-06-2014, whether by way of repeal or amendment as may be necessary or expedient, for the purpose of facilitating the application of such law in relation to the State of Telangana, before expiration of two years from 02-06-2014, and there upon every such law shall have effect subject to the adaptions and modifications so made until altered, repealed or amended by a competent Legislature or other competent authority;

- 2. And whereas, it has become necessary to adapt and modify The Andhra Pradesh Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Rules, are in force as on 01-06-2014 for the purpose of facilitating its application in relation to the State of Telangana;
- 3. Accordingly, the following notification will be published in the Extra-ordinary issue of the Telangana Gazette Dt:30-05-2016.

## **NOTIFICATION**

In exercise of the powers conferred by section 101 of the Andhra Pradesh Re-organization Act, 2014(Central Act No.6 of 2014), the Governor of Telangana hereby makes the following Order, namely:-

- 1. (1) This Order may be called Andhra Pradesh Persons with Disabilities (Equal Opportunities, Protection of Rights And Full Participation) Rules, 1997 (Telangana Adaptation) Order, 2016.
  - (2) It shall come into force from 2<sup>nd</sup> June, 2014.
- 2. In the Andhra Pradesh Persons with Disabilities (Equal Opportunities, Protection Of Rights And Full Participation) Rules, 1997 throughout the Rules for the words "Andhra Pradesh" occurring otherwise than in a citataion or description or title of other enactments, the word "Telangana" shall be substituted.
