4. Government after careful examination of the matter, hereby made the following amendments to the orders issued in G.O.Ms.No.20, Department for Women, Children, Disabled and Senior Citizens, Dated: 19-09-2017.

AMENDMENT

In the said G.O. in para under the heading III District level Committee

- (i) In clause (b) for the word "Six months", the word "three months" shall be substituted.
- (ii) In clause (c), after sub-clause (vi) shall be added namely,-

The following directions of the Hon'ble High Court in PIL No.238 of 2015, Dated: 06-10-2017 shall be implemented:

"(vii) the Secretaries of the respective District Legal Services Authorities shall prepare comprehensive reports regarding the implementation of G.O.Ms.No.21, Department for Women, Children, Disabled and Senior Citizens, dated: 19-09-2017 and forward the same to the respective Secretaries of the State Legal Services Authorities within two weeks of holding such meetings by the District Level Committees.

- (viii) Within two weeks thereafter, the Secretaries of State Legal Services Authority shall file appropriate applications before the Hon'ble High Court either reporting compliance of the G.O.Ms.No.21, or pointing out the deficiencies if any, during the preceding period of three months;
- (ix) As and when such applications are field, the Registry of the High Court shall appropriately number the same and post before the Bench dealing with the case."
